#### **ISSUE PRESENTED**

1. Can a foreign (Delaware) corporation, whose defective product that it marketed in California causes and will continue to cause injuries to California citizens, escape liability for those yet-to-manifest injuries by dissolving itself and relying on a Delaware law that cuts off post-dissolution suits after three years—or does California law (Corporations Code section 2010) apply to this California case, allowing post-dissolution suits without time limitation?

## WHY REVIEW SHOULD BE GRANTED

This petition presents both primary Rule 8.500 grounds for this Court's review—a direct conflict among published California appellate decisions on an important question of law: whether a foreign corporation, unlike a California corporation, can escape future liability for its past conduct (here subjecting California citizens to injuries that have not yet occurred or manifested) by simply dissolving itself.

Plaintiffs and petitioners Walter and Karen Greb¹ allege that defendant Diamond International Corporation ("Diamond"), a Delaware corporation, supplied asbestos-containing materials in the 1950s to 1970s to UC Davis, where Greb was exposed to asbestos. Opinion at 1; Joint Appendix on Appeal ("JA") 8-9. When Walter was diagnosed with terminal mesothelioma, he filed suit against Diamond (and others) on December 22, 2008. JA 1-25.

Walter was not alone—in the late 1990s into the 2000s, many victims of exposure to Diamond's asbestos were becoming sick and filing claims.<sup>2</sup> At the time, Diamond was not even conducting business, having had no operating assets or employees since 1987. But Diamond, facing a growing wave of suits, moved under Delaware law to dissolve itself effective July 1, 2005.

Walter died in September 2009, while the appeal below was pending. By order of the Court of Appeal, his wife Karen in October 2009 was "substituted as personal representative/successor in interest of Walter Greb." For brevity and consistency with the Opinion below, this Petition continues to refer to petitioners as Walter and Karen.

Reflecting Diamond's past business activity in Northern California, the San Francisco County Superior Court's web-based docket shows a steady increase this decade in suits filed against Diamond for asbestos exposure: from one in 2001 to four in 2003 and 2005 to six in 2007. See <a href="http://www.sfsuperiorcourt.org/index.aspx?page=467">http://www.sfsuperiorcourt.org/index.aspx?page=467</a> ("Name Search Query").

Then, when Greb sued Diamond just over three years later, Diamond demurred on the ground that the action is barred by Delaware law, under which "dissolved" corporations are "continued for [only] 3 years" as "bodies corporate for the purpose of prosecuting and defending suits." 8 Del. C. § 278; JA 31-41. Greb argued in opposition that this action is governed not by Delaware's three-year limit but by California Corporations Code section 2010, which places no time limit on suits against "dissolved" corporations. JA 73-76.

Diamond's demurrer presented, as the appellate court below put it, an extant "conflict in the Court of Appeal." Opinion at 8. Two published decisions from 1986 reached conflicting decisions on whether section 2010 applies to foreign corporations like Diamond:

- 1. North American Asbestos Corp. v. Superior Court (Young) (1986) 180 Cal.App.3d 902 ("North American II") holds that section 2010 "conflicts with, and prevails over, foreign corporation laws that limit survival periods of dissolved corporations." Opinion at 8; see North American II, 180 Cal.App.3d at 909-910.
- 2. Riley v. Fitzgerald (1986) 178 Cal.App.3d 871 ("Riley") holds that section 2010 "does not apply to foreign dissolved corporations." Opinion at 8; see Riley, 178 Cal.App.3d at 876-877.

That conflict is now reinforced by the Opinion below, which affirms the judgment on demurrer by following *Riley* (and rejecting *North American II*) to rule that Corporations Code section 2010 applies only to California corporations and thus provides no protection to California citizens injured by dissolved foreign corporations.

Thus, the Opinion below reinforces the lack of uniformity of decision in the Courts of Appeal, warranting this Court's review.

And review should be granted also because this appellate conflict involves an important question of law that will recur and that affects the rights of many California citizens. This is particularly true in cases involving asbestos injuries, which by their nature involve past conduct causing future injuries—a circumstance ripe for abuse by tortfeasors seeking to escape liability by dissolving. Indeed, just as to Diamond, more asbestos victims are becoming sick and filing suit each year.<sup>3</sup> And other asbestos defendants from states with post-dissolution suit limits (like Delaware) can likewise immunize themselves from future liability by dissolving.

But this is not just an asbestos-specific problem. Under the rationale of the Opinion below, any manufacturer of a defective product who is incorporated in Delaware (or a similar state) could dissolve to escape liability for injuries that will be caused by the product in the future.

California surely has a strong interest in protecting the rights of its citizens to be compensated when they are injured. And the Legislature has sought to protect those rights by imposing no time limits on lawsuits against dissolved corporations—if a corporation injures California citizens, it is responsible and cannot escape future liability by dissolving itself.

Hence, this petition presents both major criteria for obtaining this Court's review: a lack of uniformity among published appellate decisions on an important question of law that affects the rights of many California citizens and should be settled by this Court.

Petitioners respectfully request review.

#### **BACKGROUND**

#### Complaint

Walter Greb died of mesothelioma caused by exposure to asbestos. Opinion at 1. When he was diagnosed, Walter and his wife Karen Greb filed suit against (*inter alia*) respondent Diamond International Corporation ("Diamond"), alleging exposure to asbestos released from products manufactured by Diamond. *Id.*; JA 4-10.

#### Demurrer sustained

Diamond demurred to the complaint on the ground that Diamond "lacks the capacity to be sued" because Diamond "dissolved" as a Delaware corporation on July 1, 2005, and Delaware Corporations Code section 278 limits suits against dissolved corporations to only three years after dissolution. Opinion at 1-2; JA 36-38. Diamond argued that "Delaware law controls without conflict with California law," including California Corporations Code section 2010, California's "corporate survival statute," which does not temporally limit suits against dissolved corporations. Opinion at 2-3; JA 37-38.

Diamond acknowledged a "split of authority among the [California] appellate courts as to whether" section 2010 "applies to foreign corporations" like Diamond. JA 38:9-12. As Diamond noted, *Riley* held that section 2010 does not extend to foreign corporations, but *North American II* held that it does. JA 38-39; *see Riley*, 178 Cal.App.3d at 876-877; *North American II*, 180 Cal.App.3d at 909-910.

Greb opposed the demurrer, arguing that no real appellate-court conflict existed because *Riley* involved a potential suit brought <u>by</u> a dissolved foreign corporation, while *North American II* (like here) involved

a potential suit <u>against</u> a dissolved corporation—so that *North American II* governed and mandated that the demurrer be overruled. JA 73-76.

But the trial court agreed with Diamond, sustaining the demurrer. Opinion at 2; JA 114-116. The court ruled that *Riley* and *North American II* conflict and "ch[ose] to follow the reasoning" of *Riley*, ruling that section 2010 does not apply foreign corporations, so that Delaware law governs and bars plaintiffs' suit. JA 114-116. Accordingly, the trial court dismissed plaintiffs' claims against Diamond with prejudice. Opinion at 2; JA 118.

#### <u>Appeal</u>

On petitioners' appeal, the First Appellate District affirmed the judgment on demurrer. Opinion at 1. In an opinion filed April 26, 2010, the appellate court acknowledged the "conflict in the Court of Appeal" between *Riley* and *North American II. Id.* at 8-12. And the court agreed with the trial court (and *Riley*) that "section 2010 does not apply to foreign corporations." *Id.* at 12-15.

#### Finality of Opinion

The Opinion, filed April 26, became final in the Court of Appeal on May 26, 2010. Rule 8.264, subd. (b)(1).

No petition for rehearing was filed.

Petitioners timely file this Petition for Review, which must be filed within 10 days of May 26, i.e. Saturday June 5, which is extended to Monday, June 7, 2010. Rule 8.500, subd. (e)(1).

#### LEGAL DISCUSSION

I.

Review should be granted because the published Opinion below involves a lack of uniformity of decision on an important question of law that this Court should settle.

This petition warrants review of the Opinion below under both primary grounds for this Court's review:

- 1. Conflict in the Courts of Appeal: The Opinion presents a conflict among three published appellate decisions as to whether Corporations Code section 2010 applies to foreign corporations. The Opinion and *Riley* hold that it does not; *North American II* holds that it does. This Court should grant review to decide this issue and thus restore uniformity of decision. *See* Part A below.
- 2. **Important question of law:** Whether section 2010 applies to foreign corporations is also an important question of law that this Court should settle—the issue affects many California citizens and will continue to recur. *See* Part B below.

Finally, we also show briefly that the Opinion's reasoning for following *Riley* and rejecting *North American II* is suspect and should be scrutinized by this Court. *See* Part C below.

# A. Lack of uniformity of decision: The Opinion reinforces a split among the appellate courts.

This Court should grant review first because this case presents a lack of uniformity among the published appellate decisions: *Riley* and the Opinion below hold that Corporations Code section 2010 does not apply to foreign corporations; *North American II* holds to the contrary.

1. Corporations Code section 2010, applying to "corporations," does not expressly state whether that term includes foreign corporations.

Petitioners ask this Court to grant review to determine whether Corporations Code section 2010, allowing suits against dissolved "corporations" without temporal limitation, applies to foreign (and not just California) corporations.

Section 2010 itself does not specify the breadth of its use of the term "corporation":

A corporation which is dissolved nevertheless continues to exist for the purpose of winding up its affairs, prosecuting and defending actions by or against it . . . .

Corps. Code § 2010, subd. (a).

Hence, the appellate courts have sought to construe whether section 2010's use of "corporation" includes foreign corporations—with conflicting results.

2. North American II: Section 2010 must apply to foreign corporations because otherwise those corporations would be treated more favorably than domestic corporations.

In 1986, the appellate court in *North American II* held that Corporations Code section 2010 applies to both foreign and domestic corporations. *North American II*, 180 Cal.App.3d at 908; *see* Opinion at 9.

North American II acknowledged that section 2010 does not specify whether "corporation" is limited and thus construed the section in light of the entire Corporations Code and California constitutional law. *Id.* at 907-908. For the court, the "key to interpreting section 2010" was former Article XII, section 15 of the California constitution, which provided that foreign

corporations shall not transact business in California under "more favorable conditions" than those applied to domestic corporations:

No corporation organized outside the limits of this State shall be allowed to transact business within this State on more favorable conditions than are prescribed by law to similar corporations organized under the laws of this State.

Because this constitutional provision was in effect when the original version of section 2010 was enacted, it clearly applied—and mandated interpretation of that section as applying to <u>all</u> corporations. Otherwise, foreign corporations would operate in more "favorable conditions," able to escape liability for past conduct by dissolving. *See North American II*, 180 Cal.App.3d at 908.

And although the constitutional provision was repealed in 1972, it was repealed as "obsolete and unnecessary" because other constitutional and statutory provisions assured "[e]qual treatment of foreign and domestic corporations." *Id.* at 909. Thus, the repeal was a "housekeeping measure" that effected "no change in law or policy." *Id.* 

Accordingly, *North American II* held that section 2010 applies to foreign and domestic corporations. 

Id. at 910. Because California law thus conflicted with the law of the defendant's state of incorporation (Illinois, with a two-year limit on post-dissolution suits), *North American II* applied standard choice-of-law analysis, concluding that California law governs because "California's interests would be more impaired by application of

<sup>&</sup>lt;sup>4</sup> In so holding, the *North American II* court reversed its own earlier holding in *North American Asbestos Corp. v. Superior Court* (1982) 128 Cal.App.3d 138 ("*North American I*"), in which the court had not considered the effect of California's constitutional provisions mandating equal treatment of foreign and domestic corporations.

Illinois law than would Illinois' interests by application of California law."<sup>5</sup> *Id.* at 905, 907.

This Court has cited the holding of *North American II* with at least tacit approval. In *Peñasquitos, Inc. v. Superior Court (Barbee)* (1991) 53 Cal.3d 1180, this Court held that section 2010 allows suits against dissolved corporations whether the suits are filed before or after dissolution. In reaching that conclusion, this Court discussed *North American II* at length, specifically reciting that case's holding that section 2010 "is not limited to dissolved California corporations, but also applies to dissolved foreign corporations." *Id.* at 1187-1188. And again this year, this Court cited *North American II* as the governing law in California, which this Court described as "holding" that "California law [is] applicable when the plaintiff was exposed to asbestos in California by a company incorporated in another state, where plaintiff's action against the company would have been barred as untimely under the other state's law." *McCann v. Foster Wheeler LLC* (2010) 48 Cal.4th 68, 101.

# 3. Riley: Section 2010 applies only to domestic corporations.

Also in 1986, another appellate court held, contrary to *North American II*, that section 2010 does not apply to foreign corporations. *See Riley*, 178 Cal.App.3d at 876-877.

<sup>&</sup>lt;sup>5</sup> Here, petitioners have argued that the same choice-of-law analysis applies—*i.e.*, that here California law prevails over Delaware law under the governmental-interest analysis. See Appellant's Opening Brief on Appeal ("AOB") at 21-25; cf. Respondent's Brief on Appeal ("RB") at 42-44 (arguing the contrary). But the Opinion below did not reach this question, finding no conflict of law based on its holding that California's section 2010 does not apply to Delaware corporations.

<sup>&</sup>lt;sup>6</sup> As discussed further in Part I.C below, the Opinion below discarded this Court's tacit approval of *North American II* in *Peñasquitos* and *McCann* as "dicta" that the appellate court was "not bound to follow." Opinion at 12.

Unlike *North American II*, which involved a suit against a dissolved corporation, *Riley* involved a post-dissolution suit <u>by</u> the corporation. Despite this distinction, *Riley* held that section 2010 does not extend to foreign corporations, whether suing or being sued. *Id*.

Riley did not consider the effect of the California Constitution on the interpretation of section 2010, as North American II did. Indeed, because Riley was filed two months before North American II, Riley relied expressly on the earlier analysis in North American I (id. at 876)—analysis that the North American II court would soon disavow.

# 4. The Opinion below acknowledges the extant conflict and follows *Riley*.

The Opinion below acknowledges that *North American II* and *Riley* constitute an extant "conflict in the Court of Appeal" on the issue of whether section 2010 "appl[ies] to foreign dissolved corporations." Opinion at 8.

The Opinion first sets forth the analyses of the two earlier decisions. Opinion at 9-10. The Opinion then criticizes *North American II* as resting on "somewhat convoluted reasoning." *Id.* at 9. And the Opinion finds it "[i]mportant" that *North American II* "did not acknowledge the conflicting case of *Riley*." *Id.* at 10.

But the Opinion does not acknowledge that because *Riley* had itself rested on the earlier decision in *North American I*, the *North American II* court's repudiation of its earlier decision made discussion of *Riley* unnecessary.

In sum, the Opinion below reinforces that there is a "lack of uniformity of decision" on whether section 2010 applies to foreign corporations.

Trial courts facing this issue will be confronted with two different analytical approaches and will not know how to rule.

This Court should grant review to decide this issue and provide stability and guidance to the California courts.

# B. Important question of law: Whether foreign corporations can escape California liability by dissolving is an important issue that affects many Californians and will recur.

This Court should grant review also because the Opinion below presents an important question of law that should be settled by this Court.

Specifically, the issue of a foreign corporation's post-dissolution liability for pre-dissolution misconduct affects many California citizens and is sure to recur. This issue will arise anytime a defendant's present conduct remains susceptible of causing injuries in the future—any defendant (from a state that limits post-dissolution liability) who is anticipating future liability can avoid or limit it by dissolving.

Asbestos cases like this one are typical. Because asbestos diseases are latent, manifesting years or even decades after asbestos exposure, defendants who contributed to causing asbestos exposures can readily anticipate future liability. If such a defendant is incorporated in a state (like Delaware) with a temporal limit on post-dissolution suits, the Opinion below allows the defendant to escape its liability by dissolving.

Indeed, that appears to be just what Diamond is trying to do here. As noted above, Diamond moved to dissolve itself effective 2005—as California lawsuits against it had increased, with more on the horizon.

Moreover, although asbestos cases are typical, this is not just an asbestos-specific problem. For example, the same issue will arise with any

manufacturer of a defective product that is anticipated to cause injuries in the future—e.g., a product that was widely distributed and that the defendant learns has a dangerous defect. Such a manufacturer (in Delaware, etc.), instead of taking steps to prevent any future injuries (such as by a product recall), could reasonably choose to dissolve, knowing that it would soon cut off any future liability.

That result may be the legislative choice in other states (like Delaware) that place a premium on the protection of corporate interests.

But it is not the policy of California. Our Legislature has instead placed a premium on protecting its citizens, including by placing no temporal limits on post-dissolution suits against culpable corporate actors.

This Court should advance California's legislative policy by granting review to consider and settle this important question of law.

# C. The Opinion's rationale is suspect and should be scrutinized by this Court.

Finally, this Court should grant review because the Opinion's various rationales for following *Riley* (and rejecting *North American II*) are suspect—so that a reversal on the merits is likely.

- 1. The Opinion is wrong to criticize *North American II* for failing to "acknowledge" *Riley*. Opinion at 10. As noted above, *Riley* rested on *North American I*. Thus, when the *North American II* court reversed itself, it did not need to address *Riley* or any other case that had followed its earlier rationale.
- 2. The Opinion fails to refute *North American II*'s discussion of the effect of the constitutional guarantee of equal treatment of foreign and domestic corporations. The Opinion does call the discussion "somewhat

convoluted." Opinion at 9. But the Opinion never addresses the merits of the argument.

Instead, the Opinion avoids the argument by asserting that it need not be considered because section 2010 is supposedly "clear on its face," so that "legislative intent" need not be considered. *Id.* at 10.

But section 2010 is <u>not</u> "clear on its face." It is ambiguous as to whether it applies to foreign corporations—an ambiguity that has caused different appellate courts to interpret the section differently.

3. The Opinion improperly discards this Court's tacit approval of North American II in Peñasquitos and McCann. As noted above, Peñasquitos discussed North American II at length, repeating without criticism the holding that section 2010 applies to foreign corporations. Peñasquitos, 53 Cal.3d at 1187-1188. And again this year, McCann cited North American II as governing law in this area.

The Opinion tosses *Peñasquitos* and *McCann* aside, finding it "[s]ignificant" that this Court "did not discuss or disapprove the holding of *Riley*." Opinion at 12. But this Court in *Peñasquitos* was most certainly aware of *Riley*, citing it within the decision's general discussion. *See Peñasquitos*, 53 Cal.3d at 1184. Nevertheless, this Court analyzed *North American II* at length and tacitly approved its holding (contrary to *Riley*).

4. The Opinion concludes that section 2010 does not apply to foreign corporations because, if it did, it supposedly "would render" other sections of the Corporations Code (including sections 102 and 162) "meaningless." Opinion at 15.

But the Opinion's analysis of other Corporations Code sections is unduly selective—other sections of the Code are adversely affected by the Opinion's holding. For example, the Opinion holds that section 2010 does

not apply to foreign corporations because it does not "stat[e] so explicitly." Opinion at 14; *accord id.* at 15 ("[T]he Legislature well knew when to expressly apply particular statues in the code to foreign corporations."). In other words, the Code's use of the word "corporations" means "domestic corporations" <u>unless</u> the Legislature "explicitly" included foreign corporations.

But this construction renders other sections of the Corporations Code meaningless or absurd. For example, section 105 provides that a "corporation or association may be sued as provided in the Code of Civil Procedure." Corps. Code § 105. Under the Opinion, because the section does not expressly include "foreign" corporations, can only domestic corporations be sued in California?

5. The Opinion incorrectly distinguishes the U.S. Supreme Court's decision in *Clark v. Williard* (1934) 292 U.S. 112, 54 S.Ct. 615.

North American II cited Clark to support its holding that section 2010 must apply to foreign corporations in light of the California constitutional provision that foreign corporations cannot do business in California under "more favorable conditions" than domestic corporations. North American II, 180 Cal.App.3d at 908. As North American II noted, Clark held that a "similar provision of the Montana constitution" necessarily meant that any burdens placed on domestic corporations about capacity to be sued were also placed on any "foreign corporation licensed to transact intrastate business in" Montana. Id. (citing Clark, 292 U.S. at 119). Accordingly, petitioners cited Clark in the court below. AOB at 15-16.

But the Opinion below brushes *Clark* aside with the bare statement that "California's Corporations Code does not contain a similar provision" to the one in Montana. Opinion at 14. But the Opinion ignores that the

"similar provision" is from California's Constitution—a provision that was repealed only because it was unnecessarily duplicative.

#### **CONCLUSION**

This petition presents a clear case for this Court's review—an undisputed conflict among the appellate courts on an important question of law that affects many California citizens. This Court should grant review to resolve that question and thus provide needed guidance to the lower courts.

Plaintiffs Walter Greb (now deceased) and his wife Karen Greb appeal from the order of the trial court sustaining, without leave to amend, defendant Diamond International Corporation's demurrer to the complaint. The court concluded defendant, a dissolved Delaware corporation, lacked the capacity to be sued because plaintiffs' lawsuit was filed more than three years after defendant's dissolution. We affirm.

#### FACTUAL BACKGROUND AND PROCEDURAL HISTORY

On December 22, 2008, plaintiffs filed a complaint for personal injury and loss of consortium against defendant and several other defendants. The complaint alleged Mr. Greb had suffered injury from exposure to asbestos and asbestos-containing products.

On February 13, 2009, defendant filed a demurrer to the complaint. In the demurrer, defendant alleged it had obtained a corporate dissolution in accordance with the laws of Delaware on July 1, 2005. It asserted it lacked the capacity to be sued when the present complaint was filed because Delaware General Corporation Law section 278 provides that a dissolved corporation shall continue to exist for purposes of winding up its affairs, including prosecuting and defending lawsuits, for a period of only three years

from the date of dissolution. Because plaintiffs' complaint was filed more than three years after the dissolution, defendant claimed the lawsuit was barred.

On March 4, 2009, plaintiffs filed their opposition to defendant's demurrer. They argued the lawsuit was permitted under California Corporations Code section 2010 (section 2010), which they asserted took precedence over Delaware law. After the hearing on the demurrer, defendant was allowed to file a surreply brief, which it did on March 19, 2009.

On May 1, 2009, the trial court sustained defendant's demurrer to the complaint without leave to amend.

On June 2, 2009, the trial court filed its order dismissing the complaint with prejudice. This appeal followed.<sup>1</sup>

#### **DISCUSSION**

#### I. Standard of Review

The resolution of the present case turns on whether California Corporations Code section 2010 applies to a dissolved Delaware corporation. Appellate courts may independently determine the proper interpretation of a statute, as it entails the resolution of a pure question of law. We therefore apply a de novo standard of review. (Farm Raised Salmon Cases (2008) 42 Cal.4th 1077, 1089, fn. 10 [72 Cal.Rptr.3d 112, 175 P.3d 1170].)

#### II. Alleged Conflict of Law

It is undisputed that the instant lawsuit was filed on December 22, 2008, more than three years after July 1, 2005, the date on which defendant formally dissolved. Relying on *North American Asbestos Corp. v. Superior Court* (1986) 180 Cal.App.3d 902 [225 Cal.Rptr. 877] (*North American II*), plaintiffs claim California Corporations Code section 2010 permits lawsuits to be filed against a dissolved foreign corporation irrespective of the date of dissolution. California Corporations Code section 2010 provides that "A

corporation which is dissolved nevertheless continues to exist for the purpose of winding up its affairs, prosecuting and defending actions by or against it . . . ." It further states that "No action or proceeding to which a corporation is a party abates by the dissolution of the corporation or by reason of proceedings for winding up and dissolution thereof." Invoking choice-of-law principles, plaintiffs contend the trial court should have applied California law rather than the three-year limitation contained in title 8, section 278 of the Delaware General Corporation Law.

Analysis of a choice-of-law question proceeds in three steps: "First, the court determines whether the relevant law of each of the potentially affected jurisdictions with regard to the particular issue in question is the same or different. Second, if there is a difference, the court examines each jurisdiction's interest in the application of its own law under the circumstances of the particular case to determine whether a true conflict exists. Third, if the court finds that there is a true conflict, it carefully evaluates and compares the nature and strength of the interest of each jurisdiction in the application of its own law 'to determine which state's interest would be more impaired if its policy were subordinated to the policy of the other state' [citation], and then ultimately applies 'the law of the state whose interest would be the more impaired if its law were not applied.' [Citation.]" (*Kearney v. Salomon Smith Barney, Inc.* (2006) 39 Cal.4th 95, 107–108 [45 Cal.Rptr.3d 730, 137 P.3d 914].) We note, however, "The fact that two states are involved does not in itself indicate that there is a 'conflict of laws' or 'choice of law' problem." (*Hurtado v. Superior Court* (1974) 11 Cal.3d 574, 580 [114 Cal.Rptr. 106, 522 P.2d 666].)

## III. Dissolved Corporations at Common Law

"At common law, upon a dissolution, a corporation ceased to exist for any purpose. It could not be bound civilly nor prosecuted criminally any more than a natural person who had died." (J. C. Peacock, Inc. v. Hasko (1960) 184 Cal.App.2d 142, 150 [7 Cal.Rptr. 490]; see also Title Co. v. Wilcox Bldg. Corp. (1937) 302 U.S. 120, 124-125 [82 L.Ed. 147, 58 S.Ct. 125].) In response to this consequence, principles of equity were implemented to create a judicial concept known as the "trust fund doctrine." (Delaney P. & R. Co. v. Crystal etc. Co. (1928) 88 Cal.App. 784, 790-791.) This rule allowed creditors an equitable right to follow corporate assets after a dissolution, so that the assets were held in a trust which gave the creditors superior claim to that of the shareholders of the corporation. Over time, jurisdictions found the trust fund doctrine a "fuzzy" concept to implement and legislatures developed "wind-up" statutes, sharp and definite, to regulate corporate liability and obligations postdissolution. (15A Fletcher Cyclopedia of the Law of Corporations (2009) § 7373, pp. 65-69; Riley v. Fitzgerald (1986) 178 Cal.App.3d 871, 878–879 [223 Cal.Rptr. 889] (Riley).) "[S]hareholders nonetheless possess an important statutory interest in the final and certain termination of their involvement with the affairs of a dissolving corporation." (Pacific Scene, Inc. v. Peñasquitos, Inc. (1988) 46 Cal.3d 407, 416 [250 Cal.Rptr. 651, 758 P.2d 1182].)

Under the Restatement Second of Conflict of Laws, whether a corporation continues its existence after it has dissolved or been suspended is decided by the state of incorporation. (Rest.2d Conf. of Laws, §299(1).) This principle applies even where corporate assets are situated elsewhere or all corporate business is conducted in other states. (Rest.2d Conf. of Laws, § 299(1), com. a, p. 295.) Additionally, states of incorporation will often have "wind-up" statutes that extend corporate life facilitating the opportunity for creditor claims against the dissolved business; such laws are recognized in other states including the forum state. (Rest.2d Conf. of Laws, § 299(2), coms. (d) & (e), pp. 295–296.)

Most states, including Delaware, limit the period within which a newly dissolved corporation may sue or be sued postdissolution. Moreover, it is the state of incorporation

that will generally control this extended existence based on legislative acquiescence. "But corporations exist for specific purposes, and only by legislative act, so that if the life of the corporation is to continue even only for litigating purposes it is necessary that there should be some statutory authority for the prolongation. The matter is really not procedural or controlled by the rules of the court in which the litigation pends. *It concerns the fundamental law of the corporation enacted by the State which brought the corporation into being.*" (Oklahoma Gas Co. v. Oklahoma (1927) 273 U.S. 257, 259–260 [71 L.Ed. 634, 47 S.Ct. 391], emphasis added; see also Bazan v. Kux Machine Co. (1971) 52 Wisc. 2d 325, 333–334 [190 N.W.2d 521, 525] [products liability claim]; *Johnson v. Helicopter & Airplane Services Corp.* (D.Md. 1975) 404 F.Supp. 726, 729 [products liability claim]; *Stone v. Gibson Refrigerator Sales Corporation* (E.D.Pa. 1973) 366 F.Supp. 733, 734 [products liability claim].)

California's corporation law, however – specifically Corporations Code section 2010 – sets forth no time limitation for suing a dissolved California corporation. Resolution of this case thus turns on whether California Corporations Code section 2010 may be applied to corporations incorporated in states, such as Delaware, with statutes that do set time limits on lawsuits involving corporate parties.

# IV. Delaware Law Regarding Dissolved Corporations

Delaware courts have held that "the existence or nonexistence of a Delaware corporation is governed by Delaware law." (*In re Transamerica Airlines, Inc.* (Del. Ch. May 25, 2007, Civ. A. No. 1039-VCP) 2007 Del. Ch. Lexis 68, \*63.) Section 278 of the Delaware General Corporation Law provides, in part: "All corporations, whether they expire by their own limitation or are otherwise dissolved, shall nevertheless be continued, for the term of 3 years from such expiration or dissolution or for such longer period as the Court of Chancery shall in its discretion direct, [as] bodies corporate for the purpose of prosecuting and defending suits, whether civil, criminal or administrative, by or against them, and of enabling them gradually to settle and close their business, to dispose of and convey their property, to discharge their liabilities and to distribute to their stockholders any remaining assets, but not for the purpose of continuing the business for which the

corporation was organized." Based on this provision, Delaware courts have held that new lawsuits may not be initiated against the dissolved corporation after the three-year period has expired. (*In re Dow Chemical International, Inc.* (Del. Ch. Nov. 18, 2008, Civ. A. No. 3972-CC) 2008 Del. Ch. Lexis 147, \*2.)

Delaware courts have observed that the state's survival statute may operate to the detriment of parties, such as plaintiffs, whose claims arise after the expiration of the corporate survival period: "This modern scheme still leaves open the question, what, if any, rights are afforded to persons who have no claim against a corporation at the time of its dissolution, or during the statutory wind-up period, but who do thereafter acquire such a claim. Such a person might, for example, be a tort claimant who is injured by an arguably defective product some time after, perhaps years after, the corporation has been dissolved, and its affairs finally wound-up. It would seem apparent that such a person could not sue the dissolved corporation itself. Section 278 continues the corporation's existence beyond the statutory three year winding-up period 'solely' for the purpose of concluding pending litigation." (*In re RegO Co.* (1992) Del. Ch., Civ. A. No. 11651 [623 A.2d 92, 96].)

In the recent case of *Territory of the United States Virgin Islands v. Goldman, Sachs & Co.* (2007) Del. Ch., Civ. A. No. 2505-VCS [937 A.2d 760], the creditors of a dissolved Delaware corporation attempted to sue the corporation's former shareholders more than three years after its dissolution. The Delaware court held that because no judgment could be recovered against a dissolved Delaware corporation after the three-year survival limit under Delaware General Corporation Law section 278, a suit could not be maintained against the shareholders of the corporation under Delaware General Corporation Law section 325, subdivision (b).<sup>3</sup> (*Goldman, Sachs, supra,* at p. 789.)

Courts in other jurisdictions have also held that Delaware General Corporation Law section 278 operates to bar lawsuits brought against dissolved Delaware corporations after the three-year period. "Although not technically a statute of limitations, [section 278] has been held to be 'a clear expression of a legislative policy normally prohibiting the commencement of actions by or against dissolved corporations more than three years after their dissolution.' [Citation.] Courts have consistently concluded that upon expiration of the three-year period, the corporation ceases to exist as a legal entity and no claims may be asserted against it. [Citations.] As the complaint in this case was filed in 1994, almost thirteen years after [the corporate defendant] was dissolved, the Town's assertion of state law claims against [the defendant] is prohibited by Delaware law." (Town of Oyster Bay v. Occidental Chemical Corp. (E.D.N.Y. 1997) 987 F.Supp. 182, 211.)

Delaware's three-year survival statute was also enforced by the Second Circuit Court of Appeals. In *Marsh v. Rosenbloom* (2d Cir. 2007) 499 F.3d 165, the court found that the New York state plaintiffs were barred from asserting a CERCLA<sup>4</sup> claim against a Delaware corporation and the corporation's former shareholders because the three-year survival period had expired before the lawsuit was filed. (*Marsh, supra*, at pp. 176, 184.) In so holding, the court explained "Delaware's post-dissolution statute . . . was enacted in order 'to formalize the continued existence of corporate assets and to provide a mechanism for the assertion of claims as part of the "winding up" process . . . [continuing] the corporation's existence by operation of law.' [Citation.] Like other post-dissolution statutes, section 278 provides that 'any suit against the corporation, which was filed before dissolution or during the three year statutory wind-up period, does not abate, even on the expiration of the wind-up period.' [Citation.] When the wind-up

period expires, however, so does the corporation's capacity to be sued." (*Id.* at pp. 172–173, fn. omitted.)<sup>5</sup>

In *Town of Oyster Bay* and *Marsh*, the alleged tortuous conduct predated the dissolution of the particular Delaware corporation. Yet, because the lawsuits were filed more than three years after the enterprises dissolved, the statutory purpose of Delaware General Corporation Law section 278 kicked in. The wind-up period had passed and consequently, the corporations' ability to be held responsible for alleged injury terminated.

## V. Conflict in the Court of Appeal

California, as a general rule, has routinely held the law of the state of incorporation determines the consequence of corporate dissolution. Citing the Restatement of Conflict of Laws, one court has noted: "'It appears to be settled law that the effect of the dissolution of a corporation, or its expiration otherwise, depends upon the law of its domicile [citations] . . . .' [Citations.]" (*Macmillan Petroleum Corp. v. Griffin* (1950) 99 Cal.App.2d 523, 528 [222 P.2d 69]; see also, *Fidelity Metals Corp. v. Risley* (1946) 77 Cal.App.2d 377, 381 [175 P.2d 592] [and cases cited therein].)

With this background in mind, we proceed to consider the merits of the present case. The parties acknowledge that two California appellate cases published within two months of each other in 1986 frame the issue in this appeal: *Riley, supra*, 178 Cal.App.3d 871, and *North American II, supra*, 180 Cal.App.3d 902. *Riley* holds that California Corporations Code section 2010 does not apply to foreign dissolved corporations. (*Riley, supra*, at p. 876–877.) *North American II* holds that California Corporations Code section 2010 conflicts with, and prevails over, foreign corporation laws that limit survival periods of dissolved corporations. (*North American II, supra*, at pp. 909–910.)

Instead, they argue that under rules of equity, the Delaware courts have the power to extend the three-year period if the case supports this choice. #### A. North American II

In *North American II*, the defendant, a dissolved Illinois corporation, had brought a motion for summary judgment on the ground that the plaintiffs' lawsuit was barred because it was filed more than two years after the corporation had dissolved. (*North American II*, *supra*, 180 Cal.App.3d 902, 904.) When the complaint was filed, Illinois law provided that the dissolution of a corporation did "not impair any remedy for a liability incurred prior to dissolution 'if action or other proceeding thereon is commenced within two years after the date of such dissolution[]' (Ill. Rev. Stat., ch. 32, § 157.94 (1977)[])" unless a recognized exception applied. (*Id.* at p. 905.) The corporation had previously filed its articles of dissolution and had received a certificate of dissolution from the Secretary of State of Illinois on May 19, 1978. The lawsuit at issue was filed on December 18, 1980, more than two years later. (*Ibid.*) After proceeding with a choice-of-law analysis, the appellate court held the trial court was correct in applying California law instead of Illinois law and in denying the motion for summary judgment. Central to this holding was the court's finding that California Corporations Code section 2010 applies to foreign corporations. (*North American II*, *supra*, at p. 908.)

Interestingly, the opinion in *North American II* was a reversal of that same court's reasoning as expressed in *North American Asbestos Corp. v. Superior Court* (1982) 128 Cal.App.3d 138 [179 Cal.Rptr. 889] (*North American I*).<sup>6</sup> In arriving at its revised holding, the court in *North American II* recognized it had stated in *North American I* that California Corporations Code section 2010 applies only to domestic corporations. (*North American II*, *supra*, 180 Cal.App.3d 902, 908.) Following somewhat convoluted reasoning, the court reversed its prior conclusion by turning to former article XII, section 15 of the California Constitution, a provision that was repealed in 1972. (*North American II*, *supra*, at p. 908.) That section, adopted in 1879, had stated: "No corporation organized outside the limits of this State shall be allowed to transact business

within this State on more favorable conditions than are prescribed by law to similar corporations organized under the laws of this State." The *North American II* court concluded that, consistent with the constitutional provision, California Corporations Code section 2010 was intended to apply to both foreign and domestic corporations when its predecessor was first enacted in 1929. *(North American II, supra, at p. 908.)* While the court acknowledged definitional sections in the Corporations Code had been amended after 1929 "so that the term 'corporation' used in Corporations Code section 2010 could arguably have come to mean only a domestic corporation," *(North American II, supra, at p. 908)* the court concluded the electorate did not intend to alter the original meaning of Corporations Code section 2010 when it repealed article XII, section 15 of the California Constitution. *(North American II, supra, at pp. 908–909.)* 

Repeating the reasoning of *North American II*, plaintiffs here contend the 1972 repeal of article XII, section 15, of the California Constitution shows a legislative intent that California Corporations Code section 2010 apply to foreign corporations. It is well established, however, that legislative intent should not be resorted to where a statute is clear on its face. "In determining legislative intent, courts look first to the words of the statute itself: if those words have a well-established meaning, as we hold they do here, there is no need for construction and courts should not indulge in it." (*Arnett v. Dal Cielo* (1996) 14 Cal.4th 4, 24 [56 Cal.Rptr.2d 706, 923 P.2d 1].)

#### B. Riley

Importantly, the majority in *North American II* did not acknowledge the conflicting case of *Riley*, a Second District case that was published some two months earlier. In *Riley*, the sole shareholders of a Texas corporation had filed a lawsuit on behalf of the corporation after expiration of the three-year postdissolution survival period provided by Texas law. (*Riley, supra*, 178 Cal.App.3d 871, 873.) On appeal, the

One commentator pointed out that former California Civil Code section 399 would *not* apply to foreign corporations because of the narrow statutory definition of "corporation" then found in former Civil Code section 278. (Note, *Foreign Corporations: Continuance of Existence After Dissolution* (1947) 35 Cal. L.Rev. 306, 309.) In relevant language, California Corporations Code section 2010 and its predecessor California Civil Code section 399 are similar, suggesting no change in legislative intent.

plaintiffs claimed California Corporations Code section 2010 created a conflict with the Texas statute and that California law should apply. (*Riley, supra,* at pp. 875–876.) In disagreeing with this contention, the appellate court in *Riley* observed: "It is settled law in California that the effect of corporate dissolution or expiration depends upon the law of its domicile, and a defunct foreign corporation has no greater capacity or higher standing to initiate or maintain an action in the forum state than it would have in its domiciliary state." (*Id.* at p. 876.) Citing to *North American I*, the court in *Riley* concluded that California Corporations Code section 2010 does not apply to foreign corporations. (*Riley, supra,* at pp. 876–877.) The court also observed that California Corporations Code section 2115 specifies the California Corporations Code provisions that "apply to foreign corporations to the exclusion of the law of the jurisdiction in which they are incorporated. Conspicuous by its absence is section 2010." (*Riley, supra,* at p. 876.) The court reasoned that the effect of corporate dissolution or extinguishment depends upon the law of the corporation's domicile. (*Ibid.*)

Plaintiffs attempt to distinguish *Riley* because the out-of-state corporate shareholders in that case had brought suit against California residents and entities, whereas *North American II*, like the case at bar, involved California residents suing a foreign corporation. They claim *Riley* is therefore not "on point." Plaintiffs also contend that the discussion concerning California Corporations Code section 2010 in *Riley* was dicta because the plaintiffs in that case "had already stipulated that Texas law applied" and that they had therefore "waived the choice of law issue." While the court in *Riley* acknowledged the parties stipulated that Texas law applied in the case, the *decision* holds "even if Rileys did *not* waive the issue [of choice of law], Texas law would still apply."

To come within the purview of California Corporations Code section 2115, a foreign corporation must meet two prerequisites. First, it must transact more than one-half of its business in California. Second, more than one-half of the corporation's voting securities must be held by persons with California addresses. If section 2115 applies, California law is deemed to control such matters as the annual election of directors, the directors' standard of care, limitations on corporate distributions in cash or property, the requirement for annual shareholders' meetings and remedies for the same if not timely held, limitations on the sale of assets, dissenters' rights; records and reports, actions by the Attorney General and inspection rights. (See Corp. Code, § 2115, subd. (b).)

(*Riley, supra,* 178 Cal.App.3d 871, 875, emphasis added.) Plaintiffs still argue that the trial court in the present case was bound to follow *North American II* and should therefore have overruled defendant's demurrer. We are not persuaded that the trial court erred and, in any event, the argument is inapposite because we are reviewing the issue as a matter of law and are not ourselves bound by other Court of Appeal decisions.

Plaintiffs also rely on *Peñasquitos, Inc. v. Superior Court* (1991) 53 Cal.3d 1180 [283 Cal.Rptr. 135, 812 P.2d 154]. In that case, the Supreme Court held that parties may bring suit against dissolved corporations for damages that occurred or are discovered after dissolution. *Peñasquitos* involved homeowners who sued a dissolved California corporation that had improperly graded their housing lots. In concluding that California Corporations Code section 2010 applied, the court described both *North American* opinions. Significantly, the court did not discuss or disapprove the holding in *Riley*, even though it was clearly aware of that case as it cited to *Riley* in a string cite after noting that "[a]t common law, the dissolution of a corporation was treated like the death of a natural person . . . ." (*Peñasquitos, supra*, at p. 1184.) As the facts of *Peñasquitos* did not involve a foreign corporation, the court's discussion of *North American II* is dicta only, which we are not bound to follow. (*People v. Macias* (1997) 16 Cal.4th 739, 743 [66 Cal.Rptr.2d 659, 941 P.2d 838].) This court also makes a similar observation of the reference to *North American II* in the recent case of *McCann v. Foster Wheeler LLC* (2010) 48 Cal.4th 68, 101 [105 Cal.Rptr.3d 378, 225 P.3d 516].

#### C. California Corporations Code section 2010 does not apply to foreign corporations

California Corporations Code section 102 provides that, with certain exceptions not applicable here, the provisions of the Corporations Code apply to domestic corporations only, and that application to other corporations is permitted only "to the extent *expressly included* in a particular provision of this division." (Italics added.)

California Corporations Code section 2010 makes no mention of foreign corporations. In contrast, for example, California Corporations Code section 1501 (annual report to shareholders) states at subdivision (g): "This section applies to any domestic corporation and also to a foreign corporation having its principal executive office in this state or customarily holding meetings of its board in this state."

Plaintiffs claim that California Corporations Code section 102 applies to all foreign corporations, relying on subdivision (a)'s reference to "corporations organized under this division." They reason that section 102 sets forth "two categories of corporations:" "corporations organized under this division' and "domestic corporations' not subject to the specified divisions or parts. They further argue that "corporations organized under this division' must be read to include foreign corporations because a contrary interpretation would render the statutory language superfluous. The argument is flawed.

In the first place, plaintiffs do not cite to any authority for the proposition that foreign corporations are covered under California's general corporation law division. It is also a substantial stretch to conclude that a corporation from another state can fairly be characterized as one "organized" under the California Corporations Code. Moreover, plaintiffs' position conflicts with California Corporations Code section 162, which provides: "Corporation,' unless otherwise expressly provided, refers only to a corporation organized under this division or a corporation subject to this division under

<sup>&</sup>quot;(c) Neither the repeals effected by the enactment or reenactment of this division nor the enactment of this title nor the amendment thereof shall impair or take away any existing liability or cause of action against any corporation, its shareholders, directors, or officers incurred prior to the time of the enactment, reenactment, or amendment."

See also California Corporations Code section 162.

the provisions of subdivision (a) of Section 102." In our view, these statutes evince a clear intent to limit the Corporations Code's general application to domestic corporations.

Further, the Corporations Code does include sections that apply specifically to foreign corporations. Chapter 21 (commencing with § 2100) contains many provisions that apply to foreign corporations. Significantly, as noted by the appellate court in *Riley, supra,* 178 Cal.App.3d 871, 876, section 2115, which identifies all of the chapters and sections of the California Corporations Code that apply to foreign corporations meeting certain threshold requirements, does not mention section 2010.

Again relying on *North American II, supra,* 180 Cal.App.3d 902, plaintiffs argue that California Corporations Code section 2115 "only applies to the 'mechanics of corporate life which would ordinarily be directed just to domestic corporations'" (see *North American II, supra,* at p. 910) and is limited to corporations that meet its threshold requirements. Further, they argue that California Corporations Code section 2010 is not the type of "mechanical rule" that one would expect to have been enumerated by Corporations Code section 2115. Suffice it to say, we disagree with the reasoning of *North American II,* and therefore find this argument to be without merit. Had the Legislature intended for Corporations Code section 2010 to apply to foreign corporations, it would have stated so explicitly.

Clark v. Williard (1934) 292 U.S. 112 [78 L.Ed. 1160, 54 S.Ct. 615] does not compel a different conclusion. In that case the United States Supreme Court upheld a Montana court's conclusion that a Montana statute allowed suit against a dissolved Iowa corporation because the statute provided that all foreign corporations licensed to do business in Montana were subject to all liabilities, restrictions, and duties imposed upon corporations of like character organized under the laws of Montana. (Id. at pp. 115, 119–120.) The same rationale does not apply in the present case because California's Corporations Code does not contain a similar provision. In sum, we conclude Delaware law controls whether defendant is amenable to suit following dissolution. This conclusion obviates the need to proceed any further with a choice-of-law analysis. As the

instant lawsuit was filed more than three years after defendant's dissolution, the trial court correctly sustained defendant's demurrer to the complaint.

#### DISPOSITION

To adopt the interpretation propounded by appellant would render particular sections such as section 102 and section 162 of the California Corporations Code meaningless. With California Corporations Code section 2115 as an example, we conclude the Legislature well knew when to expressly apply particular statutes in the code to foreign corporations. California Corporations Code section 2010, however, does not do so. The trial court's orders sustaining defendant's demurrer and dismissing the case with prejudice are affirmed.
