Dear Chief Justice Guerrero and Associates Justices;

This office represents Make UC A Good Neighbor and The People's Park Historic District Advocacy Group ("Good Neighbor") in this matter. I write in response to the September 8, 2023, letter from counsel for Defendants and Respondents The Regents of the University of California, et al. ("UC") regarding the enactment of Assembly Bill No. 1307 (2023-2024 Reg. Sess.) (AB 1307).

UC's counsel proposes a procedure by which the parties submit simultaneous supplemental briefs and supplemental reply briefs regarding this new law. But the letter is vague regarding the legal questions that might be raised by the enactment of AB 1307 that Good Neighbor would be expected to brief.

Rather than forcing Good Neighbor to guess what consequences UC believes this law may have on the Court's resolution of this matter, Good Neighbor respectfully requests that the Court order UC to file a supplemental brief regarding what effect, if any, this enactment has on the Court's resolution of this matter; followed by Good Neighbor having the opportunity to file a responsive supplemental brief 20 days after UC files its supplemental brief; followed by UC having the opportunity to file a supplemental reply brief after Good Neighbor files its supplemental responsive brief.


