**APPELLANT’S RENEWED REQUEST FOR JUDICIAL  
NOTICE OF REDACTED COURT RECORDS  
IN SUPPORT OF CONSOLIDATED ANSWER  
TO AMICI BRIEFS**

Under California Rules of Court, rules 8.54 and 8.252(a), and California Evidence Code sections 459, subdivision (a) and 452, subdivision (d)(1), Defendant, Cross-Complainant, and Appellant Curtis Olson respectfully requests the Court take judicial notice of the court records and certified shorthand reporter’s transcript of judicial proceedings between the parties.

The records of which judicial notice is requested are trial court records from Jane Doe’s second civil harassment restraining order proceeding as discussed in Olson’s consolidated answer to the multiple amicus briefs. (Consol. Ans. 6–14.) In these proceedings, following a multiple day bench trial, Olson successfully prevailed against Doe’s request for a civil harassment restraining order against him based on insufficient evidence to support her allegations against him.

A true and correct copy of each of these court records, redacted in accordance with Civil Code section 1708.85, subdivision (f)(2)(B)(i), is submitted in the manner prescribed by the Evidence Code, the California Rules of Court, and the Rules of the California Supreme Court, as follows:

(d)(1) [“Judicial notice may be taken of the following matters to the extent that they are not embraced within Section 451: ... (d) Records of (1) any court of this state[.]”].)

Jane Doe’s name, identifying characteristics, and the

alphanumeric digits of the case number have been redacted under Civil Code section 1708.85, though unredacted copies are available.

## **MEMORANDUM OF POINTS AND AUTHORITIES**

### **1. Redacted Records of Which Judicial Notice Is Requested and the Reasons and Authorities for Judicial Notice**

Under California Rules of Court, rule 8.252(a)(2), the foregoing documents are relevant to this Court's consideration of the amici briefs submitted in this review and Appellant's consolidated answer to them as discussed throughout it. (Consol. Ans. 6–13.)

These court records are the proper subject of judicial notice under Evidence Code sections 459, subdivision (a), and 452, subdivision (d)(1). (Evid. Code, §§ 459, subd. (a) [“The reviewing court may take judicial notice of any matter specified in Section 452.”]; 452, subd. (d)(1) [“Judicial notice may be taken of the following matters to the extent that they are not embraced within Section 451: ... (d) Records of (1) any court of this state[.]”]; see e.g., *Flores v. Arroyo* (1961) 56 Cal.2d 492, 496 [15 Cal.Rptr. 87, 364 P.2d 263] [“Courts take judicial notice of the public and private official acts of the judicial departments of this state and of the United States[.]”]; *Drummond v. Desmarais* (2009) 176 Cal.App.4th 439, 447, fn. 3 [98 Cal.Rptr.3d 183] [reviewing court may refer to the register of actions on the trial court's website]; accord, *Rosales Martinez v. Palmer* (9th Cir. 2014) 753 F.3d 890, 894 [“It is well established that we may take judicial notice of judicial proceedings in other courts.”].)

## CONCLUSION

Olson respectfully requests that the Court take judicial notice of the court records and certified shorthand reporter's proceedings of the Superior Court of the County of Los Angeles involving Jane Doe and Olson in which Olson prevailed against Doe's request for a civil harassment restraining order based on insufficient evidence to support her allegations against him.
