INTRODUCTION

Pursuant to Evidence Code section 459 and rule 8.252(a) of the California Rules of Court, respondent respectfully asks this Court to take judicial notice of its own order denying review in case number S042283. Respondent has appended a copy of the docket from that case.

POINTS AND AUTHORITIES IN SUPPORT OF REQUEST FOR JUDICIAL NOTICE

In respondent's brief, respondent has provided a summary of this case's long, complex history. (RB 1-20.) In recounting this history, respondent refers to appellant's petition for review in case no. S042283, and to this Court's order denying review. (RB 10 & fn. 7.) In that petition, appellant sought review of the Court of Appeal's denial of his petition for writ of mandate, in which he had challenged the venue transfer to Orange County. (See 1 Orange County Superior Court Clerk's Transcript 93-130.) On September 29, 1994, this Court denied review. The order denying review, however, does not appear in the appellate record. Under Evidence Code section 452, subdivision (c), this Court may take judicial notice of the official acts of any court of this state. Consequently, respondent asks this Court to take judicial notice of its own order denying review in case no. S042283.

CONCLUSION

For the reasons stated, respondent respectfully asks this Court to take judicial notice of its order of September 29, 1994, denying review in case no. S042283.
