
Dear Mr. McGuire:

The purpose of this letter is to advise the Court of appellant's focus issues and to request 45 minutes for argument, 30 minutes for opening argument and 15 minutes for rebuttal.

Appellant will focus on the following issues: 1) the trial court committed prejudicial error when it dismissed juror number two; 2) the trial court committed prejudicial error by allowing Willard Lewis to testify that he heard co-defendant at the scene identify appellant by name; 3) the trial court erred by insisting on further deliberations and refusing to declare a mistrial when the jury declared that it was hopelessly deadlocked.

Although I am uncertain at this time whether the entire 45 minutes will be required (moot court is to be held 03/21/14 and I will have a better idea of total time needed, appellant requests the full 45 minutes permitted for argument; split 30 minutes for his opening argument and 15 minutes for rebuttal.
