## **INTRODUCTION**

The County requests that the Court take judicial notice of two sets of materials—(1) the five volumes of legislative history of the Meyers-Milias-Brown Act that the Court of Appeal judicially noticed, and (2) the fact that SEIU Local 721 maintains a website at which it posts information related to its representation of Los Angeles County employees.

## **LEGISLATIVE HISTORY**

Pursuant to Evidence Code section 459 and Rule 8.252, California Rules of Court, the County asks the Court to take judicial notice of the documents contained in the bound volumes titled “Documents for which Judicial Notice Is Requested – AB 3109” and “Documents for which Judicial Notice Is Requested – SB 1228.” The documents are portions of the legislative history of two bills that form a part of what is known as the Meyers-Milias Brown Act. They were obtained from the Legislative Intent Service in Woodland, California and submitted under the declarations of Dorothy H. Thomson, as true and correct copies of the originals.

The County presented these materials to the Court of Appeal, which granted the request for judicial notice on November 17, 2009, as reflected in its docket.

### **This Court may rely on materials compiled by the Legislative Intent Service**

Under Evidence Code section 459 appellate courts have the same right and power to take judicial notice as do the trial courts. “In an effort to discern legislative intent, an appellate court is entitled to take judicial notice of the various legislative materials, including committee reports,

underlying the enactment of a statute.”<sup>1</sup> “The Court of Appeal granted RVLG’s request for judicial notice of documents bearing on the legislative history of section . . . We have likewise granted RVLG’s request in this court to take judicial notice of these same legislative history materials.”<sup>2</sup>

Documents supplied by the Legislative Intent Service have consistently been utilized by the Supreme Court and the Courts of Appeal, either when proffered by the litigants or on their own motion, and the Legislative Intent Service has often been mentioned in appellate opinions as the source of the documents.<sup>3</sup>

The declaration of a Legislative Intent Service attorney to the effect that the copies provided are true and correct copies of the originals is sufficient to authenticate the materials.<sup>4</sup>

### **Courts have taken judicial notice of the types of documents submitted with this request**

Courts have taken judicial notice of the same types of legislative documents submitted with this request, as follows:

- Various versions of a legislative bill.<sup>5</sup>
- Committee analyses.<sup>6</sup>

- Legislative committee bill analysis worksheet and other documents from a legislative committee file.<sup>7</sup>
- Legislative author letters to governor<sup>8</sup>

### **The documents are relevant**

The types of legislative documents submitted herewith are routinely considered by the reviewing courts of this State when considering the background and purpose of specific bills and statutes. Here, this material sheds considerable light on the circumstances leading to the passage of Assembly Bill 3109 in 1961 and Senate Bill 1228 in 1968, and the language ultimately arrived at through the legislative process for the text of Government Code sections 3505 and 3507.

### **SEIU LOCAL 721's WEBISTE**

Evidence Code section 452, subdivision (h) permits this Court to take judicial notice of “facts and propositions that are not reasonably subject to dispute and are capable of immediate and accurate determination by resort to sources of reasonably indisputable accuracy.” That SEIU Local 721 maintains a website is not reasonably subject to dispute, and is capable of immediate and accurate determination by accessing <http://www.seiu721.org> over the Internet. The Courts of Appeal have recognized the propriety of taking judicial notice of

websites.<sup>9</sup> Attached to this request is a copy of the home page and a copy of the page entitled “Los Angeles County.”

Although the County did not ask the Court of Appeal to take judicial notice of this fact, this Court may take judicial notice because this fact is known to the SEIU and it will have the opportunity to respond to the County’s arguments regarding that fact in its reply brief.

## UFW Marchers and SEIU 721 Members Celebrate at Capitol

Marching side by side with mushroom, strawberry and grape pickers, and others that toil in the hard soil and hot California sun, made a profound impression on SEIU 721 member and retired registered nurse Rosie Martinez this past week.

"This experience has changed my life," said Martinez. "I have always supported farm workers, but now I have a profound understanding of their life and struggles. Walking side by side, caring for their sore and blistered feet, providing them medical help so they can continue their march, all their effort to make a difference in their own struggle has left me humble to have been a part of the experience."

The 13 day, 200 mile march, which started as a protest against Gov. Brown's veto of the Fair Treatment for Farm Workers Act bill, culminated with a rally at the state capitol, where organizers celebrated a compromise agreement that will strengthen the Agricultural Labor Relations Act. The full legislation will vote on the bill before the end of session this Friday.

"I have so much respect for these workers and I am proud that I was able to give them some comfort," Martinez said. "They were full of blisters but they refused to stop. I learned so much from them. They were able to stand up to their own physical adversity and continue to march. I am willing to fight the good fight on behalf of them if they need me."

Martinez and over 3,000 other marchers were joined by about 30 SEIU 721 members who boarded a bus from Los Angeles and participated in the final day of the march.

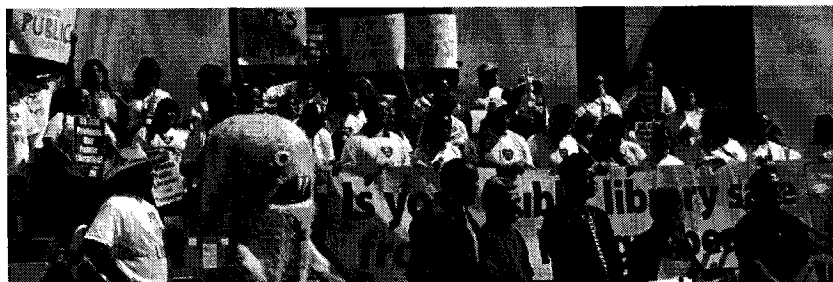

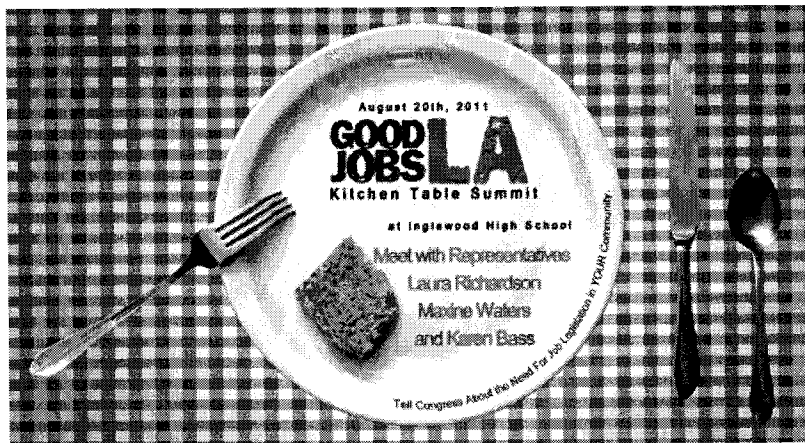

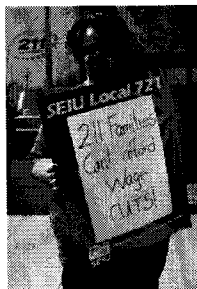
