¹We note that the People made a factual assertion in their reply brief, without citation to the record, that Mr. Needham has not received sex offender treatment while confined at the Orange County Jail. (Reply Brief, pp. 9-10.) On the contrary, Mr. Needham has received sex offender treatment at the Orange County Jail, as referenced in the evaluations, including the evaluation of the People's expert, Dr. Craig King. We believe this was inadvertent error on the People's part and not an attempt to mislead the Court.
