- 1. People v. Valencia (2017) 3 Cal.5th 347, 357, 365-367, 372-375 [declining to find Proposition 47 amended Proposition 36 when the initiative and ballot materials are silent to that possibility and observing that a contrary rule "would not protect the voters' right to directly enact laws but could very likely encourage the subversion and manipulation of that democratic right"];
- 2. People v. Harris (2017) 15 Cal.App.5th 47, 57-66 & fn. 9, review granted Nov. 21, 2017, S244792 [opinion by Division One of the Fourth Appellate District reassessing its decision in Alejandro N. v. Superior Court (2015) 238 Cal.App.4th 1209, denying DNA sample expungement after Proposition 47 resentencing, and rejecting equal protection and privacy claims associated with retention of DNA database samples collected for offenses impacted by Proposition 47].
