Pursuant to Rule 8.54 of the California Rules of Court and California Evidence Code Sections 452 and 459, Petitioners Arnette Travis and Chris Voisey hereby request that the Court take judicial notice of two exhibits offered in support of its Opening Brief on the Merits. The authenticity of the exhibits is established by the Declaration of John D. Spurling, included herein.¹

The Court may take judicial notice of "[o]fficial acts of the legislative, executive, and judicial departments ... of any state of the United States." (Evid. Code § 452(c).) The Court may also consider "facts and propositions that are not reasonably subject to dispute and are capable of immediate and accurate determination by resort to sources of reasonably indisputable accuracy." (Evid. Code § 452(h); see also § 459(a) ["The reviewing court may take judicial notice of any matter specified in Section 452."].)

Exhibit A is a certified copy of the Abstract of Judgment Respondents² recorded against Petitioner Chris Voisey's modest home in Redondo Beach, California. The Abstract of Judgment was filed in the Official Records Recorder's Office for Los Angeles County on August 15, 2019, where it was assigned Record Number 20190821104. It states that a

stay of enforcement "has not been ordered by the court" (Ex. A at p. 3), even though enforcement has been stayed since October 2, 2019, when Petitioners filed their Notice of Appeal.

Exhibit A is subject to judicial notice under sections 452 and 459. The document was recorded by an executive department of the State of California and its contents are not reasonably subject to dispute. (Cal. Evid. Code § 452(c) & (h); *Mira Overseas Consulting Ltd. v. Muse Fam. Enterprises, Ltd.* (2015) 237 Cal.App.4th 378, 386 [taking judicial notice of two recorded abstracts of judgment], as modified on denial of reh'g (June 30, 2015).)

Exhibit B is a true and correct copy of the Los Angeles County Assessor Portal's webpage for parcel number 7508-024-019, available at https://portal.assessor.lacounty.gov/parceldetail/7508024019. This webpage indicates that Petitioner Chris Voisey's home at 526 Sapphire Street, Redondo Beach, California 90277, has an assessed tax valuation for 2021 of \$910,113. The authenticity of Exhibit B is established by the Declaration of John D. Spurling, included herein.

Exhibit B is subject to judicial notice under sections 452 and 459. The webpage was prepared and published by an executive department of the State of California and its contents are not reasonably subject to dispute. (Cal. Evid. Code § 452(c) & (h); see *City of Los Angeles v. Waller* (1979) 90 Cal.App.3d 766, 775 [taking judicial notice of appraisal valuation]; *Shaw v. People ex rel. Chiang* (2009) 175 Cal.App.4th 577, 606 at fn. 10 [taking

judicial notice of existence and contents of California Department of Transportation website because "[s]uch matters are relevant and may be judicially noticed as official acts and public records"], disapproved of on other grounds by County of San Diego v. Commission on State Mandates (2018) 6 Cal.5th 196.)

Accordingly, the Court should grant this motion.


