Argument III: The Admissibility of Oscar's Identifications

Senate Bill No. 923 (Penal Code section 859.7, operative on January 1, 2020) (when effective, requiring law enforcement agencies to adopt eye witness identification procedures for photo lineups and live lineups that comply with requirements specified in the new statute, drawing on 30 years of peer-reviewed research establishing evidence-based practices to decrease the risk of misidentification).

People v. Reed (2018) 4 Cal.5th 989, 1027-1031 (dis. opn. of Liu, J.) (urging "the Legislature, the Judicial Council, or this court to develop principles that guide the admissibility of eyewitness identification evidence").

Argument V: The Erroneous Restriction of Impeachment Evidence

In re I.C. (2018) 4 Cal.5th 869, 894 (even where no evidence existed that child witness was coached or had motive to lie, child's fantastical statements – ranging from the highly significant to the mundane – were equally relevant in determining whether she was likely telling the truth about the incidents at issue).
