NOTICE OF ERRATA

Plaintiff Law Finance Group wishes to correct a typographical error in its Answer Brief on the Merits.

On page 70, final line, “trial court” should be “Court of Appeal,” such that the sentence reads, “It would be to direct the Court of Appeal to decide an alternate ground for reversing the vacatur order that the parties briefed, and that the Court of Appeal did not reach.”

This correction does not affect the brief’s substance. The gist of LFG’s Answer Brief argument containing the typographical error was, and remains, that if this Court were to reverse the Court of Appeal’s holding that vacatur was unavailable, it should direct the Court of Appeal to decide an alternate argument that LFG made in the Court of Appeal, and that the Court of Appeal found unnecessary to reach in light of its vacatur-unavailability holding.
