Dear Mr. Navarette:

I am counsel for petitioner Rico Ricardo Lopez in the abovecaptioned appeal.

Petitioner files this letter brief in reply to the Attorney General's letter brief concerning this Court's question, "What effect, if any, does Assembly Bill No. 333 (Stats. 2021, ch. 699) have on the issues presented in this case?"

The Attorney General devotes most of its letter brief to contending that Assembly Bill No. 333 ("AB 333") does not apply retroactively to the judgment against petitioner. Petitioner would note here that he does *not* argue that AB 333 applies retroactively to require the reversal of the gang enhancement or gang-murder special circumstance in his case.

However, petitioner disputes the Attorney General's claim on page 2 of its letter brief that "AB 333 has no effect on this case." For reasons of justice and racial equity, as petitioner has explained in his letter brief, AB 333 overhauled the misguided and harmful gang law that gave rise to the gang-murder special circumstance in petitioner's case. Thus AB 333 provides another compelling reason, separate and distinct from the reasons argued in petitioner's briefs on the merits, that this Court should not rely on the special circumstance to hold the alternative-theory error harmless beyond a reasonable doubt. That is AB 333's effect on this case.

Petitioner also disputes the Attorney General's assertion in footnote 2 on page 3 of its letter brief that AB 333 "would not affect . . . in any way" the inference it asks this Court to draw from the special circumstance concerning "the jury's findings on Lopez's state of mind." To the contrary, any claimed inference from the special circumstance would indeed be affected by this Court's view of AB 333. Because the special circumstance is tainted by the misguided and unjust prior gang law that authorized it, and the special circumstance could not even be proved under the newly amended gang law, this Court should decline to attribute significance to *anything* about the special circumstance, including the Attorney General's claimed inference about the jury's factfinding, which it has argued would require this Court to hold the alternative-theory error harmless.

The Attorney General also fails to consider that in Section 2(e) of AB 333, the Legislature noted, "Studies suggest that allowing a jury to hear the kind of evidence that supports a gang enhancement before it has decided whether the defendant is

guilty or not may lead to wrongful convictions." This finding by the Legislature suggests that the gang evidence admitted at petitioner's trial under the now invalid prior gang law may well have affected "the jury's findings on Lopez's state of mind" at the time it found the gang-murder special circumstance allegation true, contrary to the Attorney General's assertion in footnote 2.

Thank you for bringing this reply letter brief to the attention of the Supreme Court.
