**WOODS ON DISCIPLINE**

Recommended discipline imposed

The court orders that JON MICHAEL WOODS (Respondent), State Bar Number 181388, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and Respondent is placed on probation for two years subject to the following conditions:

1. Respondent must comply with the conditions of probation recommended by the Hearing Department of the State Bar Court in its Decision filed on May 8, 2020; and
2. At the expiration of the period of probation, if Respondent has complied with the terms of probation, the period of stayed suspension will be satisfied, and that suspension will be terminated.
