Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment, and may be collected by the State Bar through any means permitted by law.

Recommended discipline imposed

The court orders that PATRICIA MIRELES (Respondent), State Bar Number 171342, is suspended from the practice of law in California for two years, execution of that period of suspension is stayed, and Respondent is placed on probation for three years subject to the following conditions:

1. Respondent is suspended from the practice of law for the first 90 days of probation; and
2. Respondent must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on July 16, 2021; and
3. At the expiration of the period of probation, if Respondent has complied with all conditions of probation, the period of stayed suspension will be satisfied, and that suspension will be

terminated.

Respondent must provide to the State Bar's Office of Probation proof of taking and passing the Multistate Professional Responsibility Examination as recommended by the Hearing Department in its Order Approving Stipulation filed on July 16, 2021. Monetary sanctions must be paid in installments of one-third per year, with Respondent's annual fees for each of the years 2023, 2024, and 2025. If Respondent fails to pay any installment as described above, or as may be modified in writing by the State Bar or the State Bar Court, the remaining balance is due and payable immediately. Monetary sanctions are enforceable as a money judgment and may be collected by the State Bar through any means permitted by law.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment, and may be collected by the State Bar through any means permitted by law. One-third of the costs must be paid with Respondent's annual fees for each of the years 2023, 2024, and 2025. If Respondent fails to pay any installment as described above, or as may be modified in writing by the State Bar or the State Bar Court, the remaining balance is due and payable immediately.

Monetary sanctions are enforceable as a money judgment and may be collected by the State Bar through any means permitted by law.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment, and may be collected by the State Bar through any means permitted by law.

**S270469****NELSON ON DISCIPLINE**

Recommended discipline imposed: disbarred

The court orders that BRUCE EDWARD NELSON (Respondent), State Bar Number 106119, is disbarred from the practice of law and that Respondent's name is stricken from the roll of attorneys.

Respondent must make restitution to the following payees or such other recipient as may be designated by the Office of Probation or the State Bar Court (or reimburse the Client Security Fund, to the extent of any payment from the Fund to such payees, in accordance with Business and Professions Code section 6140.5). Reimbursement to the Fund is enforceable as a money judgment and may be collected by the State Bar through any means permitted by law:

- (1) James Keppler in the amount of \$11,318.40 plus 10 percent interest per year from December 18, 2016;
- (2) Stephanie Ang in the amount of \$7,431.60 plus 10 percent interest per year from December 18, 2016;
- (3) Jo-Ann Strong in the amount of \$5,444.44 plus 10 percent interest per year from March 20, 2018;
- (4) Allen Max Luger in the amount of \$7,856.50 plus 10 percent interest per year from January 6, 2017;
- (5) Allen Max Luger, as Trustee for the Berger Permanent Trust, in the amount of \$7,856.50 plus 10 percent interest per year from January 6, 2017; and
- (6) The Estate of Charles Martinez, in the amount of \$67,000 plus 10 percent interest per year from December 27, 2018.

Respondent must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7

and as a money judgment, and may be collected by the State Bar through any means permitted by law.
