Application to file over-length brief granted

Appellant's "Application for Permission to File an Overlength Supplemental Reply Brief," filed on January 6, 2026, is granted.

**PEOPLE v. BURRIS  
(NATHAN)**

Extension of time granted

Based upon Supervising Deputy State Public Defender Laura Kelly's representation that the appellant's comprehensive supplemental reply brief addressing respondent's first and second supplemental briefs is anticipated to be filed by May 12, 2026, an extension of time in which to serve and file that brief is granted to March 13, 2026. After that date, only one further extension totaling about 60 days is contemplated.

An application to file an overlength brief must be served and filed no later than 60 days before the anticipated filing date. (See Cal. Rules of Court, rule 8.631(d)(1)(A)(ii) & (B)(ii).)

Extension of time granted

Based upon Supervising Deputy State Public Defender Lisa D'Orazio's representation that the appellant's opening brief is anticipated to be filed by April 23, 2027, an extension of time in which to serve and file that brief is granted to March 16, 2026. After that date, only seven further extensions totaling about 403 additional days are contemplated.

An application to file an overlength brief must be served and filed no later than 60 days before the anticipated filing date. (See Cal. Rules of Court, rule 8.631(d)(1)(A)(ii) & (d)(2)(B).)
