Opinion filed: Judgment reversed

We therefore reverse the judgment of the Court of Appeal insofar as it ordered struck, per the anti-SLAPP statute, those claims of Serova against Sony that remained after the trial court's order, and we remand for further proceedings consistent with this opinion, including any dismissal proceedings contemplated by the parties' settlement agreement.
