Summary of Cases Accepted and Related Actions During Week of May 16, 2022

[This news release is issued to inform the public and the press of cases that the Supreme Court has accepted and of their general subject matter. The statement of the issue or issues in each case set out below does not necessarily reflect the view of the court, or define the specific issues that will be addressed by the court.]

#22-132 California-American Water Co. v. Public Utilities Commission, S271493. Original proceeding. The court issued a writ of review regarding notice and due process requirements in proceedings before the Public Utilities Commission. (See also Golden State Water Co. v. Public Utilities Commission, S269099.)

#22-133 People v. Faial, S273840. (A159026; 75 Cal.App.5th 738; San Mateo County Superior Court; SC083808.) Petition for review after the Court of Appeal remanded for resentencing and otherwise affirmed a judgment of conviction of criminal offenses. This case presents the following issue: Does Assembly Bill No. 1950 (Stats. 2020, ch. 328) apply retroactively to a defendant, serving a suspended-execution sentence, whose probation was revoked before the law went into effect?

#22-134 Golden State Water Co. v. Public Utilities Commission, S269099. Original proceeding. The court issued a writ of review regarding notice and due process requirements in proceedings before the Public Utilities Commission. (See also California-American Water Co. v. Public Utilities Commission, S271493.)

#22-135 People v. Epps, S274064. (D079593; nonpublished opinion; Riverside County Superior Court; RIF132260.) Petition for review after the Court of Appeal reversed an order denying a post-judgment motion in a criminal matter.

#22-136 People v. Pereles, S273996. (H049218; nonpublished opinion; Santa Clara County Superior Court; 186103.) Petition for review after the Court of Appeal affirmed an order denying a post-judgment motion in a criminal matter.

#22-137 People v. Rembert, S274013. (G059690; nonpublished opinion; Orange County Superior Court; C-94692.) Petition for review after the Court of Appeal reversed an order denying a post-judgment motion in a criminal matter.

#22-138 People v. Rosales, S274030. (H048876; nonpublished opinion; Santa Clara County Superior Court; CC319535.) Petition for review after the Court of Appeal reversed an order denying a post-judgment motion in a criminal matter.

The court ordered briefing in *Epps*, *Pereles*, *Rembert*, and *Rosales* deferred pending decision in *People v. Strong*, S266606 (#21-101), which presents the following issue: Does a felony-murder special circumstance finding (Pen. Code, § 190.2, subd. (a)(17)) made before *People v. Banks* (2015) 61 Cal.4th 788 and *People v. Clark* (2016) 63 Cal.4th 522 preclude a defendant from making a prima facie showing of eligibility for relief under Penal Code section 1170.95?

#22-139 People v. Pacheco, S274102. (G059940; 76 Cal.App.5th 118; Orange County Superior Court; 08WF0147.) Petition for review after the Court of Appeal reversed an order denying a post-judgment motion in a criminal matter. The court ordered briefing deferred pending decision in People v. Curiel, S272238 (#21-23), which presents the following issue: Does a jury's true finding on a gang-murder special circumstance (Pen. Code, § 190.2, subd. (a)(22)) preclude a defendant from making a prima facie showing of eligibility for resentencing under Penal Code section 1170.95?
