Summary of Cases Accepted and Related Actions During Week of December 13, 2021

[This news release is issued to inform the public and the press of cases that the Supreme Court has accepted and of their general subject matter. The statement of the issue or issues in each case set out below does not necessarily reflect the view of the court, or define the specific issues that will be addressed by the court.]

#21-553 *In re Cabrera*, S271178. (C091962; nonpublished opinion; Siskiyou County Superior Court; MCYKCRBF20076242, SCCRHCCR20189121.) Petition for review after the Court of Appeal denied a petition for writ of habeas corpus. This case presents the following issue: Did the sentencing court err by finding petitioner's conviction for battery with serious bodily injury was a serious felony (Pen. Code, §§ 667, subd. (a)(1), 1192.7, subd. (c)(8)), despite the jury's failure to reach a verdict on the allegation that petitioner personally inflicted great bodily injury in committing that offense? (See *Apprendi v. New Jersey* (2000) 530 U.S. 466; *Blakely v. Washington* (2004) 542 U.S. 296; *Cunningham v. California* (2007) 549 U.S. 270.)

#21-554 *People v. Bludworth*, S271568. (C091249; nonpublished opinion; San Joaquin County Superior Court; STKCRCNV19980016792.) Petition for review after the Court of Appeal affirmed an order denying a post-judgment motion in a criminal matter.

#21-555 *People v. Diaz*, S271698. (E076440; nonpublished opinion; Riverside County Superior Court; INF1302087.) Petition for review after the Court of Appeal affirmed an order denying a post-judgment motion in a criminal matter.

#21-556 *People v. Flemmings*, S271591. (C092553; nonpublished opinion; Sacramento County Superior Court; 97F08683.) Petition for review after the Court of Appeal affirmed an order denying a post-judgment motion in a criminal matter.

#21-557 *People v. Myles, S271574.* (B309401; nonpublished opinion; San Bernardino County Superior Court; FSB10937.) Petition for review after the Court of Appeal affirmed an order denying a post-judgment motion in a criminal matter.

#21-558 *People v. Wright, S271574.* (C091633; nonpublished opinion; Sacramento County Superior Court; 93F06757.) Petition for review after the Court of Appeal affirmed an order denying a post-judgment motion in a criminal matter.

The court ordered briefing in *Bludworth, Diaz, Flemmings, Myles, and Wright* deferred pending decision in *People v. Strong, S266606* (#21-101), which presents the following issue: Does a felony-murder special circumstance finding (Pen. Code, § 190.2, subd. (a)(17)) made before *People v. Banks* (2015) 61 Cal.4th 788 and *People v. Clark* (2016) 63 Cal.4th 522 preclude a defendant from making a prima facie showing of eligibility for relief under Penal Code section 1170.95?

#21-559 *People v. Bravo, S271782.* (E072782; 69 Cal.App.5th 1063; Riverside County Superior Court; RIF75184.) Petition for review after the Court of Appeal affirmed an order denying a post-judgment motion in a criminal matter. The court ordered briefing deferred pending decision in *People v. Espinoza, S269647* (#21-453), which presents the following issue: Did the Court of Appeal err in ruling that defendant failed to adequately corroborate his claim that immigration consequences were a paramount concern and thus that he could not demonstrate prejudice within the meaning of Penal Code section 1473.7?

#21-560 *People v. Sedillo, S271292.* (B309401; nonpublished opinion; Los Angeles County Superior Court; NA085739.) Petition for review after the Court of Appeal dismissed an appeal from an order denying a post-judgment motion in a criminal matter. The court ordered briefing deferred pending decision in *People v. Delgadillo, S266305* (#21-72), which presents the following issues: (1) What procedures must appointed counsel and the Courts of Appeal follow when counsel determines that an appeal from an order denying postconviction relief lacks arguable merit? (2) Are defendants entitled to notice of these procedures?
